## SUMMARY ANNUAL REPORT FOR BAC LOCAL UNION 15 WELFARE FUND

This is a summary of the annual report of the BAC Local Union 15 Welfare Fund, a health, dental, vision and death benefits plan (Employer Identification Number 23-7386028, Plan Number 501), for the plan year 04/01/2017 through 03/31/2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BAC Local Union 15 Welfare Fund has committed itself to pay certain Health, Dental, Vision, and Death Benefits claims incurred under the terms of the plan.

## **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$19,982,030 as of the end of plan year, compared to \$18,671,066 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$1,310,964. This change includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$9,160,794 including employer contributions of \$7,494,795, employee contributions of \$1,047,473, gains/(losses) of -\$5,017 from the sale of assets, and earnings from investments of \$534,611. Plan expenses were \$7,849,830. These expenses included \$1,094,843 in administrative expenses, \$6,754,987 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
